### SECTION 4: FIRST AID MEASURES

#### 4.1 Description of first aid measures

##### General Information:

Do not inhale dust from granules, or spray mist/aerosols. Do not use spray equipment contaminated with this product for any other purposes unless first thoroughly cleaned with a suitable cleaning detergent.

### 7.2 Conditions for safe storage

Store in the closed original packaging out of reach of children and in a dry, cool, well-ventilated area. Keep away from food, drink and animals feeding stuffs.
