DIRECTIONS:

Shake well. Mix 10ml per litre of water and apply to 5 square metres using a spray unit. For best results, apply 1 week after cutting under active growing conditions to ensure an even coverage of all foliage. Do not spray if rain is likely within 24 hours. Keep pets off treated lawns until the spray is dry.

GENERAL INFORMATION:

Onehunga weed is very common in New Zealand lawns, producing a mass of small prickles over the summer. The optimum time to apply Grosafe® Prickle Weedkiller is in October, after the majority of plants have germinated and before they set seed. A second spray in autumn will reduce the problem for next season. Do not apply below 18oC or variable results may be achieved

NOTE: Some burning may occur with young and fine turf grasses. Best practice is to wait 3-4 months before spraying newly established grass and a patch test is recommended. Do not use lawn clippings for compost or mulch until 3 cuttings after treatment. After application, clean equipment thoroughly. It is advisable to use a separate sprayer for fungicides and insecticides. Apply this product carefully. Spray drift may cause serious damage to other desirable plants. Do not apply on or around food or animal feed crops.
