Buxus, Roses and Ornamentals	Transplant Stress	6ml/1L water	Gently soak the soil around the roots then plant. Recommended to combine with Grosate BioPower Seaweed and Organic Root-Gro for increased benefit during transplant.
Lawn/Turf	Rust	6ml/1L water	Apply at first signs and repeat in 4 weeks.
Succulents	Rust	6ml/1L water	Apply at first signs and repeat in 4 weeks.

MIXING: Partially fill knapsack or watering can with water, add Buxus Blight Fighter and stir. Add Grosafe BioPower Seaweed and Organic Root-Gro next then stir. Top up with the required amount of water.
