ACTIVE INGREDIENT: Contains 360g/litre glyphosate as the isopropylamine salt in the form of a soluble concentrate.

PRECAUTIONS: Keep out of reach of children. Store in original container, tightly closed, away from foodstuffs. Avoid contact with eyes, skin and inhalation of spray mist. GENERAL INFORMATION: Knockdown® controls a wide range of grass and broadleaf weeds including couch, kikuyu, paspalum, thistles and most oxalis species. It works by moving through the plant and into the root system killing the entire plant. Brown-off may take 7-14 days after application, depending on growing conditions. Knockdown® leaves no soil residue so treated areas may be sown immediately after weeds have died. Knockdown® has no soil activity and can be used for spot treatment of weeds in rockeries, paths, garden beds, lawns and around buildings. Improved results when used with Grosafe EcoSpread®.

DIRECTIONS: Use 10ml per litre of water. Spray all leaves until just wet. For best results apply Knockdown® to healthy, actively growing plants. If rainfall occurs up to 6 hours after spraying a repeat application may be required. Do not remove weeds for 7 days after treatment to allow time for Knockdown® to circulate through the root system. Avoid contact with desirable plants; if accidentally sprayed, hose off immediately with plenty of water to reduce plant damage. Do not spray when windy. **Shelf life:** When stored appropriately this product should show no significant degradation for 2 years from date of manufacture. Contact your supplier for further information about the use of any product that is older than this.
