GENERAL INFORMATION: Knockdown® controls a wide range of grass and broadleaf weeds including couch, kikuyu, paspalum, thistles and most oxalis species. It works by moving through the plant and into the root system killing the entire plant. Brown-off may take 7-14 days after application, depending on growing conditions. Knockdown® leaves no soil residue so treated areas may be sown immediately after weeds have died. Knockdown® has no soil activity and can be used for spot treatment of weeds in rockeries, paths, garden beds, lawns and around buildings.

DIRECTIONS: Spray all leaves until just wet. For best results apply Knockdown® to healthy, actively growing plants. If rainfall occurs up to 6 hours after spraying a repeat application may be required. Do not remove weeds for 7 days after treatment to allow time for Knockdown® to circulate through the root system. Avoid contact with desirable plants; if accidentally sprayed, hose off immediately with plenty of water to reduce plant damage. Do not spray when windy. **Shelflife:** When stored appropriately this product should show no significant degradation for 2 years from date of manufacture. Contact your supplier for further information about the use of any product that is older than this.
