IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Dial 111
Spill or Leak	Wear full protective clothing including self-contained breathing apparatus. Prevent further leakage. Absorb spillage with lime or clay, collect and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings. Seek advice from the local authority regarding disposal.
Fire	Dial 111. Product may give off harmful fumes. Wear full protective clothing and breathing apparatus. Use fog, foam, powder or CO <sub>2</sub> to extinguish. Cool steel drums with water to prevent explosion by thermal expansion. Keep non involved persons away..

**FIRST AID**
