DIRECTIONS FOR USE:

Mix 50ml in 5 litres of water and spray onto 50 square metres of lawn. Apply evenly over the measured area. Apply in spring and autumn when weeds and turf are growing vigorously. Do not apply if rain is expected. Avoid treatment following long periods of dry weather. Do not apply in hot conditions. Keep pets off treated lawns until spray is dry.

GENERAL INSTRUCTIONS:

NOTE: Some burning may occur with young and fine turf grasses. Best practice is to wait 3-4 months before spraying newly established grass and a patch test is recommended. Do not use lawn clippings for compost or mulch until 3 cuttings after treatment. After application, clean equipment thoroughly. It is advisable to use a separate sprayer for fungicides and insecticides.

Apply this product carefully. Spray drift may cause serious damage to other desirable plants. Do not apply on or around food or animal feed crops

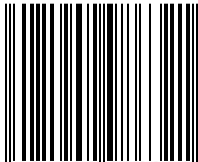
